VISA APPLICATIONS FOR RESIDENTS THAT WILL NOT WORK IN SPAIN

There are 2 different visas: **1)** for the **residence applicant** and **2)** for his/her **family members** (this must be submitted in a sibling application with the main application).

Note: *Family members means spouse and children descendant younger than 18 years old.*

Everyone who wish to reside in Spain without undertaking any lucrative activity or employment can apply submitting the requirements.

For the main applicant

Requirements:

1. **Letter addressed to the consul** explaining the motives of applying for this specific type of visa.
2. **National application form** FULLY COMPLETED and SIGNED by the applicant. *Note: For children under 18 years old, parent (father or mother) must sign instead of them.*
3. **Non-Work Residence Permit application form** (code EX-01), duly completed and signed. *Note: For children under 18 years old, parent (father or mother) must sign instead of them.*
4. **Form Modelo-790** (code 52) duly completed and signed by the applicant.
5. **Applicant must submit his application IN PERSON** in the Embassy of Spain in Riyadh.
6. **Two recent photographs** (35-45 mm) of the applicant with white background must be attached in the application form. *Must be without head covering for male applicants and without face covering for female applicants.*
7. **Original Documental proof** that show enough financial capacity for the stay in Spain. Proof of economic means to support the living expenses, including the expenses of the family for the proposed duration of stay.
8. **Original passport.** Passport has to be valid, at least, for 18 months. The passport must contain the signature or the fingerprint of the holder and 2 or more empty pages.
9. **Photocopy of the passport significant pages** (personal data, visas, etc.).
10. **Copy of a valid medical insurance** with sufficient coverage and validity for 1 year.
11. **Proof of accommodation** in Spain.
12. **Original Criminal Records** (one per each country in which the applicant has lived in the previous five years)
 - a) **Living in KSA during the last 5 years** Criminal record report must be Apostille and translated into Spanish by a sworn/certificated translator.(FROM ABSHER)
 - b) **Living abroad during the last 5 years** Criminal record report officially stamped by the Ministry of foreign affairs of the country concerned and legalized by the "Spanish embassy in that country".or Apostille and Translated to Spanish.
13. **Original Medical Report** certifying the applicant is not suffering from any infectious or contagious disease (in accordance with the provisions of the International Health Regulations 2005) with the Apostille certification and translated to Spanish .
14. **** Criminal Certificate and Medical Certificate must be legalized with the Apostille certification.** *The apostille can be requested to the Saudi authorities at the following address:*

16. **Letter mention his/her salary or pension** received, attested by the Chamber of Commerce.
17. **For non-Saudi Nationals:** Copy of Iqama and copy of the valid Exit/Re-entry document. (Translated to English or Spanish).
18. **Absher information** that shows your status in KSA (iqama validity/exit-re- entry/family etc.)

**Note: all documents to submit must be original.*

Family of resident in sibling applications

Requirements:

- 1) **Letter addressed to the consul** explaining the motives of applying for this specific type of visa.
- 2) **National application form** FULLY COMPLETED and SIGNED by the applicant. *Note: For children under 18 years old, parent (father or mother) must sign instead of them.*
- 3) **Non-Work Residence Permit application form** (code EX-01), duly completed and signed. *Note: For children under 18 years old, parent (father or mother) must sign instead of them.*
- 4) **Form Modelo-790** (code 52) duly completed and signed by the applicant.
- 5) **Two recent photographs** (35-45 mm) of the applicant with white background must be attached in the application form. *Must be without head covering for male applicants and without face covering for female applicants.*
- 6) **Documental proof** that show enough financial capacity for the stay in Spain. Proof of economic means to support the living expenses, including the expenses of the family for the proposed duration of stay.
- 7) **Original passport.** Passport has to be valid, at least, for one year. The passport must contain the signature or the fingerprint of the holder and 2 or more empty pages.
- 8) **Photocopy of the passport significant pages** (personal data, visas, etc.).
- 9) **Copy of a valid medical insurance** with sufficient coverage and validity for 1 year.
- 10) **Proof of accommodation** in Spain.
- 11) **Original Criminal Records** (one per each country in which the applicant has lived in the previous five years)
 - a) **Living in KSA during the last 5 years** Criminal record report must be Apostille and translated to Spanish by a sworn / certificated translator. (FROM ABSHER)
 - b) **Living abroad during the last 5 years** Criminal record report officially stamped by the Ministry of foreign affairs of the country concerned and legalized by the "Spanish embassy in that country" or Apostille and Translated to Spanish
- 12) **Original Medical Report** certifying the applicant is not suffering from any infectious or contagious disease (in accordance with the provisions of the International Health Regulations 2005) should be Apostille and translated to Spanish.
- 13) **Copy of approved visa** for the main applicant.
- 14) **Original family Book** that justifies the relationship with the main applicant. It must be stamped by Ministry of foreign affairs of the country concerned, translated into Spanish and legalized and Apostille.(any document issued outside the Kingdom must be certified by the Spanish embassy or Apostilled by the country that issued the document)
- 15) **For non-Saudi Nationals:** Copy of Iqama and copy of the valid Exit/Re-entry document. (Translated to English or Spanish)
- 16) **Any documents issued outside the kingdom must be certified by the Spanish embassy or apostilled by the country that issued the documents.**



ATTENTION:

The Embassy of Spain reserves the right to request additional documents whenever deemed necessary (this list of requirements is not exhaustive), may call the applicant for an interview and have a right of refusal without any explanation. In all cases the visa fee is non-refundable.

If the visa is approved, the applicant must check upon receiving his passport that the visa data are correct (personal data, dates, number of entries).

If the non-working residence visa is approved, upon arrival the applicant must apply for a Resident ID before the Spanish Authorities.
